If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of Funeral Director and Staff.....\$2,750.**

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service; arrangement conference with family or responsible party; securing signed and certified copies of death certificate, recording vital statistics; preparation and filing of necessary authorizations and permits; staff assistance at all times, including consultation and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, and others. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

**Transfer of Remains to Funeral Home .....\$ 500.**

*(Additional transportation fees apply beyond 50 miles)*

**Embalming .....\$ 700.**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Our company policy requires embalming for visitations.

## **Direct Cremation**..... From **\$ 3,250.** to **\$ 14,775.**

The charge for a direct cremation includes transfer of remains to funeral home, basic services of the funeral director and staff and cremation fee. This charge does not include the use of the facilities and staff for any visitation or ceremony, public or private. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials. The containers we offer are cardboard covered wood box or cloth covered cardboard.

1. Direct cremation with alternative container (ACC) ..... **\$ 3,500.**
2. Direct cremation with alternative container (Union) ..... **\$ 3,800.**

## **Immediate Burial**..... From **\$ 3,650.** to **\$ 15,175.**

Our charge for an immediate burial, without any attendant rites or ceremonies, includes basic services of funeral director and staff, transfer of remains to funeral home, and hearse to local cemetery. It is our company policy that burial must take place within 48 hours of the time of death.
